4. ADVERTISING

Boards may be required to display advertising chosen and supplied by the organizing authority. ISAF Regulation 20 'Advertising Code' shall apply. Media accreditation is obligatory from race director.

5. RULES

The event will be governed by:

- The rules as defined in The Racing Rules of Sailing
- Sailing Instructions,
- Notice of Race,
- The Class Rules of the participating classes,
- Notices of Race Committee and Protest Committee,
- National prescriptions of the Czech Sailing Association.

6. ELIGIBILITY

The event is open for all competitors who comply with the requirements of ISAF Regulation 19 - Eligibility Code.

7. ENTRY

Eligible competitors may enter by completing registration form at the event site and paying the entry fees. The following shall be presented upon registration:

- Czech Sailing Association license, with medical approval no older than one year
- Foreign competitors shall be members of a National Class Association which is a paid up member of the relevant international class association, or of the IWA

The entry may be signed by the helm. By signing agrees to be bound by the Racing Rules of Sailing and other documents, which governs this event.

If a competitor is under age 18, the responsibility takes a person (coach, parent, guardian, skipper), which confirms this by signing the entry form. The person assuming responsibility must be of legal age, with full legal eligibility. On entry form must be in addition to signing the name, surname, identity card number

and date of birth. The data shown is the organizer entitled to demand to verify the proof of identity. The responsible person is obliged to inform the competitor, who takes responsibility for, with all the mandatory documents, and in particular with the point 11.2 of the Competition Rules (Safety and Health protection). The responsible person must be throughout the race reachable by the organizers. The organizer may require additional personal and contact information of the person who assumed responsibility.

8. FEES

Entry fees 800 CZK.

Entry fees shall be paid in cash at registration and covers attendance at the event and 2 dinners, it does not include the accommodation fees.

Protest fees 300 CZK.

9. EQUIPMENT INSPECTION

Equipment inspection must be made by inspector before registration. Inspector will confirm the registration form by his signature. Competitors can not be registered without signature of inspector. Equipment inspections may be made at any time during the event.

14. PROTEST COMMITTEE

An 'Independent Protest Committee' will be appointed according to WCR 91(a).

15. PRIZES

Prizes will be awarded to the first three competitors of each properly constituted class/division. The champion can be declared only when 10 or more competitors are entered.

16. RIGHT TO USE NAME AND LIKENESS

In registering for the event, competitors automatically grant to the Organizing Authority the right in perpetuity to make, use and show from time to time at their discretion, any motion pictures, still pictures and live, taped or filmed television and other reproduction of them, taken during the period of the event, for the said Event as defined in the Notice of Race and Sailing Instructions in which he/she participates without compensation.

17. DISCLAIMER OF LIABILITY AND INSURANCE

Competitors participate in the event entirely at their own risk (see WCR 4 - Decision to Race). The organizing authority or any of their officials or representatives or the sponsors or their officials or representatives will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the event. In registering for the event, competitor declares having valid third-party liability insurance with minimal cover of CZK 9,000,000 per event or equivalent (as required by point 2.4 of Czech Sailing Association National prescriptions).

18. SUPPORT BOATS

Support boats shall be registered at the race office.

19. ACCOMMODATIONS

Accommodation is possible in own tents or caravans in the area of sports club Rozkošní piráti and follows the valid price list.
