SAILING INSTRUCTIONS

In a rule of the contest instruction, the [DP] mark means the rule for the violation of the law, on the decision of the protest committee, on the exclusion may be smaller.

- 1. RULES
- 1.1. Competition In the Sailing Competition Rules (hereinafter: RRS) specified rules, including Appendix B of the RRS. THE definition (g) of the rules of the participating classes are international and the 2018 tournament of the Hungarian Surfing Championships.
- 1.2. Competitors must comply with World Sailing 21. (Doping Rules) its provisions.
- 1.3. Competitors are obliged to wear them during the entire stay on the water an individual floating device except for the replacement or alignment of clothing short periods. Violation of the rule is a protest to the competitor uncontrolled exclusion. This modifies RRS Rule 40.
- 1.4. If there is a discrepancy between the languages, the English text is governed.
- 1.5. If there is a contradiction between the Tournament Notice and the Tournament Statement, a Competition instructions apply.
- 2. [DP] ADVERTISING
- 2.1. Vessels may be required to be selected by the organizing organization to display an ad. If this rule is violated, World Sailing Regulation 20.9.2 applies.
- 2.2. The advertisement chosen and provided by the organizing organization is a competitors must have on their own the RRS Appendix GRS and the according to class specifications.

- 3. PARTICIPATION AND NOMENCLATURE
- 3.1. The following classes can be started in the race:

- ID card
- Medical doctor license for Hungarian competitors
- Valid competition license or competition license sheet
- 4. INFORMATION FROM COMPETITORS
- 4.1. The competition office is located at Balatonaligán, on the waterway of the HVO.
- 4.2. Announcements to contestants at Balatonaligán, the waterway of the HVO suspended on an official bulletin board.

Completion of a race (1) is necessary for the validity of the race.14.2. If fewer or four races are completed, the serial number of a ship is the sum of the scores of all races.14.3. If the number of completed races is five or more, the score of a series of berths is the sum of all race points calculated without its worst point.15. TIMELINES AND TARGETS15.1. The scheduled time of the races is 20-25 minutes.15.2. At the targeting time window (the time after the first launching ship) for each class 15 minutes.15.3. Ships not targeting within the target

time window will be assessed as DNF without negotiation. This modifies rules RRS 35, azA4 and A5.16. PROTESTS AND WARRANTY APPLICATIONS16.1. Claim forms are available at the competition office and must be filed within the appropriate deadline.16.2. The time limit for each class will be 60 minutes after • the last last cruiser of the last day of the race has reached the finish line or • the "AP is over" or "N on the A" is set.17. [DP] INSTALLATION, SURVEILLANCE CHECK 17.1. Competitors are responsible for ensuring that their equipment meets class specifications and that they are stored in a place designated by the organizing organization.17.2. During the race the equipment can be checked at any time.18. OFFICIAL VESSELS18.1. Contest vessels are flagged on a white background with RC flags.18.2. The activities of official ships can not be the basis of a remedy initiated by a ship. This modifies the RRS 60.1 (b) rule. [Race Direction] 619. LIMITED AREAS FOR SUPPORTING BOATS 19.1. Supporting vessels should be outside the areas where boats are competing and can not stay in the extension of the race. [DP] 2.19. The restriction of SI 19.1 does not apply to a support vessel that provides assistance to a ship or competitor in distress.20. EXCLUSION OF LIABILITY20.1. Competitors are solely responsible for their participation in the race. See Rule RRS 4, Decision on Participation in the Race. The organizing organization, the competition organization and the sponsors shall not be liable for any material damages, personal injury or death related to the competition before, during, or after the event.21. BIZTOSÍTÁS21.1. Each participating vessel must have a valid liability insurance covering at least up to EUR 500 000 or a sufficient collateral.22. MÉDIAJOGOK22.1. Competitors agree that the Hungarian Surfing Association and the contest supporters will be free to use photo and video footage on the event for free, unlimited use, advertising and other purposes.
